### 2014-2015 International Karaoke Contest

For the first time ever, the Moose will also crown an International Karaoke Champion who will have worked his or her way up from the Lodge competitions all the way to the international finals. Come see what kind of talent our Brothers and Co-workers possess – the winner may be from your Lodge or Chapter!

All active members of the Loyal Order of Moose and Women of the Moose are eligible to participate and the top 12 finalists will travel to the 2015 International Convention to compete for the top prize in front of a packed convention audience. Each finalist will receive round-trip airfare (or equivalent) and two nights lodging at the Opryland Hotel with cash prizes of \$5,000, \$2,000, and \$1,000 going to the top three performers.

Singers will first enter their local Lodge/Chapter competition; then move up through District and Association competitions in order to qualify for the finale at the Nashville Convention. Association winners will be responsible for sending DVD's or audio recordings to Moose International, where music professionals and media contacts from around the Chicagoland area will narrow the field to the final 12.

She will be spearheading Oregon's efforts to help maintain Oregon Residence at Mooseheart and helping the girls who are currently living in the home. There are 10 girls, aged 12 to 16. She is confident that we are going to do wonderful things in the future for them.

#### Laurie writes:

Oregon Moose Association Lodges and Chapters need to have a person in contact with Mooseheart and the Oregon Home. Someone to be the go between too get information out to our Lodges and Chapters on what our girls need and to let our Lodges and Chapters know who's there and what they are doing. Sending Birthday & Christmas cards out to them and just

making sure they know we are here for them. Some Lodges and Chapters are already interacting with the Oregon girls in some way. If you could email me on what your Lodge or Chapter is doing, I would appreciate it. This will help me in the coming months to determine what we need or can do. One thing is certain- We don't

want to make any of the girls feel left out or to treat any one girl with special gifts. Our projects/gift giving must be centered on all of the girls in the home. If you would like to take on a specific project please consider all of the girls in the home.

The OMA knows that not every Lodge or Chapter will be able to help 100%... if at all. Your Lodge and Chapter's obligations to your Moose Home, Moose Charities and to the OMA projects must be met first. We can all work together for the Oregon Home as one. Here are a couple of examples: If one lodge/chapter wants to supply hair products but can't for all of the girls, than we ask a 2nd or 3rd lodge/chapter until the need is met. If your Lodge/Chapter can meet a full need, that is fabulous. If you want to take on a project and you need to do it in two phases let's work on that. The possibilities are endless on what we can do.


Please let me know if you would like to do something; I will make sure we are not duplicating projects with the Oregon Home Consultant and the Family Teachers and that we have the correct information before the project starts. Remember the cost of postage to mail items is high and we have different sized girls and tastes. Although it's not as satisfying as picking out something yourself and putting it in a box and mailing it, the girls may have a great time shopping for their own individualities and needs. VISA gift cards are acceptable everywhere and this would eliminate postage and returns. The Family Teachers could just take them shopping. A \$300 gift card ÷ by 10 is \$30.00 per girl.
